We are excited that the Nursery program has moved to the Chaya Sarah Tessler Campus at 6106 N. California. The newly renovated facilities provide ample space, new classrooms, and a playground area to enhance your children's Nursery experience. Our Nursery program hours are 8:30 A.M. to 2:00 P.M. Monday through Thursday, and until 12:00 P.M. on Friday. Nursery tuition is \$500 per month. We offer an optional afternoon Nursery program Monday through Thursday from 2 to 3:30 P.M. (for an additional charge). All students entering Nursery for the 2018-19 school year should be 4 years old by November 30, 2018.

JDBY-YTT is a participant in JUF Right Start, which is a gift voucher program that substantially helps offset the cost of preschool tuition. As of now, the JUF provides up to \$2,000 for the first child in a family attending a Jewish early childhood program, and \$500 for additional siblings attending a Jewish early childhood program for the first time. In addition, some families may be eligible for childcare subsidies from the State of Illinois, depending on household income and employment. Please contact the Business Office for more details.
