SCHOLARSHIP TAX CREDIT (STC) -> A STEP-BY-STEP GUIDE

INTRODUCTION

Thank you for your interest in making a **Scholarship Tax Credit (STC)** donation.

This is a 3-part process that, while not difficult, must be followed step by step to ensure your scholarship tax credit donation is successfully processed.

These steps include:

Setting up a MyTax Illinois Account



Reserving Your Tax Credit



Donating to a Scholarship Granting Organization (SGO)

Unless you already have a MyTax Illinois Account, this process can take **1-2 weeks** to complete because you must wait to receive a "Letter ID" from the State of Illinois. Once you receive the Letter ID, you can quickly complete the rest of the process.

PART B: ACCOUNT SETUP

- ✓ The Letter ID you received in the mail
- Now that you have your Letter ID, return to https://mytax.illinois.gov
- In the top right section under the login fields, click Sign Up then Next.
- Select how you want to activate your account (for example, using your social security number or license number) and fill it in. Hit Enter.
- Select Yes to the question: "Are you trying to activate your My Tax Illinois Account for Individual Income Tax?"
- Once you click **Yes**, the screen will expand with additional fields.
- Enter your Letter ID. It's located in the middle of the letter you received in the mail and begins with "CNXXX"
- On the top right of the Letter ID you received in the mail ("MyTax Illinois Account Access Request"), you'll see "Account ID". Your IL-PIN is those 8 digits, not including the P.



Fill in your IL-PIN OR Prior Year Adjusted Gross Income.

Enter your contact information, choose a username and password, select a security question and answer, and confirm your email and password.

<< IMPORTANT >>

Write down your username and password and keep it in a safe place! You'll need it going forward:

Click the blue **Submit** button in the bottom right corner to complete the form.

You will see a confirmation pop up informing you that you are the account's primary user. Click **OK**.

You will see a confirmation page. Print it if you'd like.

Click OK and you'll be directed back to https://mytax.illinois.gov

RESERVE YOUR TAX CREDIT

PART A: LOGGING IN

On https://mytax.illinois.gov, on the top right, enter your username and password and click Log in .

You'll be asked to either use an Authentication App, or receive security codes by Email. If you feel comfortable using an authentication app, feel free to select that option. The following instructions will be for the "Email" option.

Click Add Email

Enter your email and click Save

An email with a six-digit verification code will be sent to the email address you provided. Open that email, and enter the code and click **Confirm**.

IF THIS IS YOUR FIRST TIME LOGGING IN

AFTER 9/7/2021 you'll be prompted to set up two-step verification. This is an additional security feature recently added to the MyTax Illinois website.

PART B: MAKE YOUR PLEDGE

STEP 2

	Now that your MyTax Illinois account is set up and you are on your MyTax homepage, you can reserve your tax credit.
	On the right side of the white "Account" rectangle, click the third link that says View more account options .
	On the next screen, on the left side under "Account Options", click the third link that says Contribute to Invest in Kids .
	Tick the acknowledgment checkbox and click Next .
	Tick the checkbox for "Invest In Kids Region" and click Next .
	 Under your name and address, fill in Region – Select Region 1 – Cook County from the drop-down menu.
	Fill in the Scholarship Granting Organization – Select Big Shoulders Fund .
2	Fill in your pledge amount and re-enter it in the box below.
	Tick the authorization checkbox and enter your email address.
	Click the blue Submit button on the bottom right.
	Re-enter your MyTax password and click OK.
	A confirmation page will appear telling you that your application has been successfully submitted.
NUESTIONS	Click OK and you'll be redirected to your MyTax Illinois "More account options" page.

PART C: SAVE YOUR CONTRIBUTION AUTHORIZATION CERTIFICATE

On your MyTax Illinois "More account options" page, on the right side under "Letters and Messages", click the top link that says **View Account Letters**.

Under "Letters", click on the bolded Invest in Kids Contributn Appl link.

<< IMPORTANT >>

If you don't see the "Invest in Kids Contributn Appl", try using the Search function.

The file should have **2 pages**:

✓ Page 1 is an approval of your application for a Contribution Authorization Certificate (CAC).

✓ Page 2 shows your donation details, including authorized contribution amount on the right, and your 10-digit certificate number located on the 2nd line on the top left. Keep your certificate number handy, as you'll need it again later.

Download the file and save it in a place where you'll be able to find it in the future, such as your Desktop.

] Name it "Contribution Authorization Certificate" or "CAC" with today's date so you can easily identify it.

<< IMPORTANT >>

You must provide a copy of this certificate to the Scholarship Granting Organization, in this case, Big Shoulders Fund. You have 60 days from the date you reserved your tax credit to donate up to the authorized contribution amount listed on your Contribution Authorization Certificate. If your certificate expired, repeat Step 2 to create a new one.

Now that you have reserved your tax credit and saved your Contribution Authorization Certificate, you are ready to donate on the **Big Shoulders Fund** website.

WHAT IS BIG SHOULDERS FUND?

For more than 30 years, **Big Shoulders Fund** has supported schools in high-need areas throughout Chicago, providing new opportunities for many deserving families. More recently, **Big Shoulders Fund** was approved by the Illinois Department of Revenue to participate as a **Scholarship Granting Organization (SGO)** for the state's tax credit scholarship program. As an **SGO**, it processes donations and awards scholarships for this program.

Before making a donation on the Big Shoulders Fund website, you must send an email to: sgo@bigshouldersfund.org with a copy of your Contribution Authorization Certificate (CAC).

To ensure your donation reaches JDBY-YTT, please cc: stc@jdbyytt.org on this email.

The email should include:

Subject line – "CAC attached."

Body of the email – this should include mention of the Contribution Authorization Certificate (CAC) you are attaching, the name of the school(s) you are restricting funds to, and the amount you are donating to each school.

For example: "Hello, attached is my Contribution Authorization Certificate. Please restrict my donation of \$X to JDBY-YTT."

OR: "Hello, attached is my Contribution Authorization Certificate. Please designate \$X to JDBY-YTT, and \$X to X School."

Attachment – a copy of your CAC.

MAKE YOUR ONLINE CREDIT CARD DONATION:

Once you have sent your CAC to Big Shoulders Fund, you can access Big Shoulders Fund's donation page at:



- Select your donation amount or hit 'other' and enter your amount manually.
- Enter your 10-digit certificate number. This is located on the 2nd line of the 2nd page of your CAC, near the top left.

Select Region 1.

Select Yes to restrict your donation.

- Enter the name(s) of the school(s) to which you are restricting your donation, as well as the amount(s) designated for each school. This must match the information you included in your email to
 Big Shoulders Fund. Please write "JDBY-YTT" to donate to our school. If you're donating to multiple schools, you can write "See email" in this space.
- Click **Yes** to allow **Big Shoulders Fund** to inform the school(s) so they can be sure that they receive your donation.

Big Shoulders asks a question about a school with no applicants. JDBY-YTT recommends selecting "Yes".

Click No when asked if my gift will be matched unless you know your employer offers a corporate donation matching program. If they do, click Yes and enter the matching organization. If you aren't sure, select No and reach out to Rabbi Sammy Joseph at stc@jdbyytt.org or (773) 465-8889 ext. 680. Click No so you do not remain anonymous, or we will be unable to track your donation and ensure it goes to the school(s) of your choice.

Click on any **Big Shoulders Fund** newsletters you would like to receive.

- Select preferred salutation.
- ☐ Complete the Billing and Contact Information and Payment Details using a credit card in the name of individual named on CAC and hit submit. Please note, the additional fee to cover processing is optional.

REMINDER:

When you file your IL taxes, you will need a copy of your "Invest in Kids Certificate of Receipt" to claim the tax credit. It should be available on **https://mytax.illinois.gov** 14 days after you make your donation.

To access it, login with your username and password and click View more account options on the right. Click View Account Letters on the right, and select Invest in Kids Cert of Receipt.
